The law makers in Washington are very concerned the federal money is getting spent on perks, retirement plans, lobbying expenses and high salaries. Sen Grassy said the funds are not reaching the intended beneficiaries, in this case, the youth of Iowa, Wisconsin, and the entire country.

Based off 2026 – Glassdoor, a highly respected recruitment employment site, Average pay for the same position (CEO of a Local Chapter) of Mike Johnson in the state of Wisconsin is \$89,000 per year. In California, the average pay for a CEO at a Boys & Girls Chapter is \$56,000. “Total; salary for Boys & Girls Clubs of American CEO earn between \$111K - \$173K with a median total pay of roughly \$137,000 per year.

- Big Mike Johnson (503c) earns \$473,000.00 per year (Despite federal funding cuts, this salary is still being paid)
 - President of the USA makes \$250,000 per year
 - Dane County Sheriff makes \$162,000 per year.
 - Dane County Executive makes \$146,692 per year
- After decades of service, the Boys & Girls Club of Bulloch will permanently close their doors and stop service starting in 2026. The organization has struggles to regain financial footing after the arrest of its former CEO and his wife, who was an organizational bookkeeper. The resulting fallout in revenue from grants and contributions have been significant, and the loss of the 21st Century Grant a major blow financial and proved to be too much to overcome.
