MIDDLETON, WISCONSIN June 22nd, 2026 / Press Newswire - First Call - Proactive Publishing LLC, a vertically integrated Global Publisher located in South Central Wisconsin (USA) announces the Criminal Complaint filed (**Harassment of Patrick Franzen**) in Dane County USA against Middleton Chief of Police **Stevie “Not Ready For Prime Time” Thompson**. For his efforts to seek improvement and paying over \$12K per year in property taxes here in Middleton, Mr. Franzen is entitled to have his questions answered and when he reports of crime, followed up by the MPD is the expectation, and not being ignored consistently and up to today Thompson has ignored “ALL” of the crimes that Mr. Franzen has reported and instead has “targeted him” seeking reasons to arrest him to keep him silent. Chief Thompson has ignored over 100 emails and phone calls from Mr. Franzen dating back to 2/23/2026. Again, zero responses from over 100 requests for follow up by MPD and Chief Thompson.

He backed up his cruiser to the garage door as it appears he was planning to load something up. I have never witnessed this from a cop cruiser before as they always just drive in the drive way normally and do not back in as this cop did today. I feel they backed in because they planned to steal my stuff as they did on Wednesday, 2/25/2026 between 6:35 PM – 7:12 PM when multiple Middleton Cops where in my kitchen, unsupervised when my \$24K Rolex went missing. That morning of Wednesday, 2/25/2026, I wore my Rolex to breakfast and when I returned, I took it off and placed it on the kitchen desk. Now, keep in mind that the cop chest, body camera can only film what is in front of the camera as it is very easy for the cops to have their camera pointed one way and their hands and arms are out of site of the cameras this can steal items, especially when they know what the value is and clear MO is present (Means, Motive, and Opportunity) to still a small item worth tens of thousands of dollars for its over 6 oz. of sold gold.
